NOTICE INVITING e-TENDER

E-Tender is hereby invited for supply of **Orthopaedic Implants** from the bonafide & experienced Suppliers/ Distributors/ Retailers / Agencies/Manufacturer, to the M.R. Bangur District Hospital, 241, Desh Pran Sashmal Road, Tollygunge, Kolkata-700033 for the financial year 2023-2024.

Approximate value of the Tender: Rs.25,00,000.00 (Rupees twenty five lakhs) only

Earnest Money Deposit (EMD): Bidders have to submit EMD of amount Rs.50,000.00 (Rupees fifty thousand) online. The bidder having enrolment/registration for SSI or MSME for manufacturing/trading of **Orthopaedic Implants** may submit documents for exemption of EMD.

Terms & Conditions:-

1) The tender to be submitted in two bid systems,

(a) Technical Bid(Bid-A) comprised with the following documents in the form of pdf file,

(b) Financial Bid (Bid-B)

The bidders should be quoted the rates for the units as mentioned against each items in BOQ inclusive of all taxes and supplied at the office of the undersigned.

2) The bidders would have to get themselves registered with the e-tender portal of the Government of

West Bengal at <https://wbtenders.gov.in> and upload listed documents including inter alia, their contact details, annual turnover, credential of government supply in India

- 3) Credential of Rs.5 lakh (Rupees Five Lakhs) only/year during the last two financial years (2020-21, 2021-22) for supply of similar nature of items to this hospital or any other hospital run by Government/Semi-Government/Local Self Government should be furnished with the tender.
- 4) The bidders should have aggregate annual turnover of Rs.20 lakh (Rupees twenty lakh) only for the last two financial years (2020-21, 2021-22) will be eligible to participate in the tender.
- 5) **Bidders having the history of breach of contract with M.R.Bangur Hospital are ineligible to participate with this tender.**
- 6) A self declaration about not been blacklisted by any central or state government authority and having no case pending with any police station in India against the bidder to be submitted with the tender.
- 7) The bonafide bidders having registered office in India, manufacturing & operational unit in West Bengal can participate.
- 8) Defective or incomplete bid application shall be rejected without any assigning reason whatever.
- 9) The Tender Committee reserves the right to accept or reject any tender without assigning reason whatever.
- 10) Each bidder should be clearly mentioned the name of authorised person, postal address, e-mail address and contact number in the tender form.
- 11) If a proprietor having more than one firm/agency with same GST No., PAN, IT clearance etc. He can submit only one tender by any one of his Firm/Agency, otherwise all of his tender will be cancelled.
- 12) If the selected bidder failed to supply quality product/items, same to be returned without any claim/dispute.
- 13) Necessary taxes as applicable and deductible shall be deducted from the bill of the supplier.
- 14) Delivery of the items to be ordered for supply to the successful bidder (s) shall be made before the schedule time of OT at Equipment Store, M.R.Bangur Hospital, otherwise the items will not be received.
- 15) **CMS catalogue items available in WBSMIS will be procured directly from the vendors enlisted thereto.**
- 16) Payment shall be made to the supplier after submission of the GST tax-invoice along with supply order, delivery challan with proper receive of the items in good condition subject to the availability of fund in the respective head of account.
- 17) Within 14 days of receipt of Award of Contract (AOC) the successful bidder(s) shall execute an agreement on a Non- Judicial Stamp paper of Rs. 50/- (Rupees Fifty) only as undertaking to supply the articles as per accepted rates throughout the period mentioned above, within the stipulated time positively, otherwise it will be considered as ineligibility.
- 18) Intending bidders may note that any change in the tender, once submitted shall not be entertained and tender found incomplete, incorrect, erased, overwritten, tempered will be summarily rejected.
- 19) The Authority has the right to extend the tenure with the accepted rate and existing terms and conditions and if the services are found satisfactory.
- 20) The Accepted lowest rate will be valid for the F.Y.-2021-2022 and 2022-2023.
- 21) The following penalties shall be imposed against offences mentioned against each:

24) **Performance Security Deposit:** Successful bidder(s) have to deposit Performance Security @3% of estimated value to the RKS account of M.R.Bangur Hospital prior to agreement.

25) **All the bidders have to mandatorily quote for all the items mentioned in the BOQ. "Zero / 0" in place of rate in the BOQ will be treated as given rate and the TIA will consider the bidder will supply the item to the hospital free of cost.**

26) **Change in quantity:** TIA may at any time by written instruction vary the general scope of this Contract by 40% (forty percent) above or 40% (forty percent) below the original Contract quantity at the accepted terms & conditions.

The price for the additional quantity will be as per the quoted price of the bid.
