**Annexure I**

**Terms and Conditions & Specification**, in connection with submission of Tender for supply of the items mentioned in annexure-I, II , III & IV at M R Bangur Hospital vide memo no. **MRBH/EQ/TNDR/29 Date : 09.08.2021**

1. The interested agency/supplier has to deposit an Earnest Money of Rs 5000.00 (Rs.Five thousand) only in the form of Demand Draft drawn in favour of the "Superintendent, M R Bangur Hospital" or to be submitted the exemption certificates for SSI units, as per Govt. Rules.
2. In case of unsuccessful bidders the earnest money will be refunded within one month from the date of opening of financial bid & the successful bidders the earnest money will be refunded, after valid tender period or after fulfillment of the tender value.
3. In case of successful bidder earnest money refund will be made after acceptance of offer letter and if denies to continue then the earnest money will be forfeited.
4. The bidder has to submit copy of valid Trade License, PAN Card, P.Tax, GST registration and credential, if any along with the bid.
5. The selected agency has to supply the required no. of items within 45 days from the date of the receipt of Purchase Order. In case of any failure at the time of supply the supplier will be the only responsible for any Government Loss.
6. The decision of the Tender selection committee is final and reserves the right to accept or reject any bidder without showing any reason.
7. The Lowest rate (inclusive of all) will be selected. If the rate of two or more agencies will be same then the Tender Committee has every right to select the agency on the basis of quality as they prefer. The decision of the Tender Committee will be final.
8. Such deposited EMD will be collected within the scheduled period & the authority will not liable beyond such period.
9. **The Tender Committee has every right to reject the lowest bidder if they feel that the quality is not up to the mark and the next bidder with best quality may be selected. Decision of the tender committee regarding quality is final.**
