NOTICE INVITING TENDER

Sealed Tender is hereby invited for supply of the following **FOOD SUPPLEMENT POWDER** from the bonafide & experienced Suppliers/ Distributors/ Retailers / Agencies/Manufacturers, to the M.R.Bangur Hospital, 241 & 249 Desh Pran Sashmal Road, Tollygunge, Kolkata-700033, for one year from the date of Award of Contract (AOC).

Tenders to be Submitted in the prescribed format (Annexure-I) along with all essential documents as per check list maintaining all terms & condition as mentioned below.

Earnest Money Deposit (EMD): Bidders have to submit EMD Rs.10,000/-(Rupees ten thousand)only in the form of Demand Draft drawn in favour of the "Superintendent, M. R. Bangur Hospital". The bidder having enrolment/registration for SSI or MSME may submit documents for exemption of EMD.

Terms & Conditions:-

- 1) The tender to be submitted in two bid system,
 - (a) Technical Bid(Bid-A) comprised with the documents as per check list duly attested by authorised signatories.
 - (b) Financial Bid (Bid-B)
 - The bidders have to quote rates for the units as mentioned against each items in Annexure-II separately of taxable value and applicable taxes and supplied at the office of the undersigned.
- 2) Tender to be submitted duly superscripted "TENDER FOR FOOD SUPPLEMENT POWDER" and sealed placing two separate sealed envelope of Bid-A and Bid-B. Tender to be sent /dropped in the tender box kept in our office within the schedule time as mentioned above. The bids received after that deadline shall not be entertained under any circumstances whatsoever.
- 3) Credential of Rs.2 lakh (Rupees two lakh) per year during the last three financial years (2019-20, 2020-21, 2021-22) for supply of similar nature of items to this hospital or any other hospital run by Government/Semi-Government/Local Self Government should be furnished with the tender.
- 4) The bidders should have aggregate annual turnover of Rs.2 lakh (Rupees two lakh) per year for the last three financial years (2019-20, 2020-21,2021-22) will be eligible to participate in the tender.



- 5) A self declaration about not been blacklisted by any central or state government authority and having no case pending with any police station in India against the bidder to be submitted with the tender.
- 6) The bonafide bidders having registered office in India, manufacturing & operational unit in West Bengal can participate.
- 7) Defective or incomplete bid application shall be rejected without any assigning reason whatever.
- 8) The Tender Committee reserves the right to accept or reject any tender without assigning reason whatever.
- 9) Each Tenderer should be clearly mentioned the name and address of the farm and their contact no in the Tender form.
- 10) If a proprietor having more than one firm/agency with same GST No., PAN, IT clearance etc. He can submit only one tender by any one of his Firm/Agency, otherwise all of his tender will be cancelled.
- 11) If the selected Bidder failed to supply quality product/items, same to be returned without any claim/dispute.
- 12) Necessary taxes as applicable and deductible shall be deducted from the bill of the supplier.
- 13) Delivery of the items to be ordered for supply to the successful tenderer shall be made within 14 working days from the date of placing the order.
- 14) Payment of the bill shall be made to the supplier after submission of the bill subject to the availability of fund from the Government of West Bengal under respective head.
- 15) Within 14 days of receipt of offer letter the Successful bidder(s) shall execute an agreement on a Non-Judicial Stamp paper of Rs. 50/- (Rupees Fifty) only as undertaking to supply the articles as per accepted rates throughout the period mentioned above, within the stipulated time positively, otherwise it will be considered as ineligibility.
- 16) Intending bidder may please note that any change in the tender, once submitted shall not be entertained and tender found incomplete, incorrect, erased, overwritten, tempered will be summarily rejected.
- 17) The Authority has the right to extend the tenure with the accepted rate and existing terms and conditions and if the services are found satisfactory.
- 18) The Accepted lowest rate will be valid for one year from the date of Award of Contract (AOC).



19) The following penalties shall be imposed against offences mentioned against each:

- 20) The Language of the tender shall be in English.
- 21) Return of EMD: After finalization of the tender the EMD will be returned back to the unsuccessful bidders.
- 22) Approximate value of the Tender: Rs.5,00,000/- (Rupees five lakh only).

23) Quality Control

- 1. Quality of the product is one of the most important concerns to be remembered by the bidders and potential sellers. Items only can be passed after thorough inspection by the hospital authority to satisfy themselves with agreed quality. Product with compromised quality will immediately be rejected without keeping any liability to the buyer to compensate any transport cost.
- 2. The packaging should be done in hygienic and sealed Container/Tin to keep it safe from any contagion.
- 3. Penalty will be imposed upon the seller if any quality is found compromised by the inspection team and the amount of the penalty will be determined considering the amount of risk faced/damage occurred due its quality without any reference to the seller.
