A. General Terms & Conditions

- Bids shall be uploaded online only through www.wbtenders.gov.in. Financial bid must contain commercial documents only; including financial documents in technical bid shall lead to summary rejection.
- Bidders must upload valid PAN, GST Registration, ITR for last 2 years, Trade License, and FSSAI License/Registration along with their tender.
- EMD shall be forfeited if the bidder withdraws the bid or the successful bidder fails to supply as per the accepted offer. EMD of unsuccessful bidders shall be returned automatically after finalization.
- Tenders from blacklisted firms, or firms whose contracts were terminated for unsatisfactory supply to any Government hospital, shall not be considered.


B. Eligibility Criteria

- The bidder may be a proprietary firm, partnership firm, limited company, manufacturer, or corporate body engaged in supply to Government organisations with good repute.
- Minimum annual turnover of Rs. 10 Lakhs during each of the last two years (self-declaration required).
- Should not have been blacklisted by any Dept./Ministry of Govt. of India / Govt. of West Bengal / PSUs.
- No criminal case pending against the Proprietor/Firm/Partner or Company.

C. Quality Control

- All items must comply with the Food Safety and Standards Act, 2006 and bear valid FSSAI license/registration.
- Items shall be subject to inspection by hospital authority and/or independent laboratory. Products with compromised quality shall be rejected. Penalty may be imposed for quality failures.
- Packaging must be hygienic, sealed, and fit for safe storage.
